Tables may NOT be transferred, sold, leased, shared or sublet, in whole or in part, without approval of the Bourse Chair. No dealer will be assigned more than one table unless space is available. Dealer badges will be issued only to those listed and any last-minute changes will be considered only after the official opening of the Convention. Only those with Dealer badges and Assistant badges are allowed behind a Bourse table.

Michigan State Numismatic Society reserves the right to refuse a table to any individual, company or entity for any reason without liability, also we reserve the right to deny a dealer's assistant credentials to be behind the table. We also

reserve the right to assign table locations without recourse.
